# FBI SPECIAL AGENT COLE CROSBY AND FBI SPECIAL AGENT JAMES BUCENELL



#### FBI SPECIAL AGENT COLE CROSBY

Special Agent Cole Crosby began his law enforcement career in 2005 with the Gwinnett County Police Department in Gwinnett County, Georgia. He worked as a patrol officer and later a detective, specializing in the investigation of robberies, assaults, homicides, and the use of high tech law enforcement equipment.

Special Agent Crosby joined the FBI in 2014 and was assigned to the Tampa division working criminal violations including bank robberies, complex violent crimes, and drug trafficking. In that role, he continues to work with the latest technology and collaborate with the private sector to further the FBI's investigations and support the FBI mission.

#### FBI SPECIAL AGENT JAMES BUCENELL

Prior to joining the FBI in 2001, Special Agent (SA) Bucenell worked for Pasco County Sheriff's Office for 8 years. After graduating from the FBI Academy, he was assigned to the Lakeland Resident Agency to work drug investigations. In 2008, he was part of a multijurisdictional Task Force created to investigate the disappearance of Robert Wiles. The culmination of the yearlong investigation resulted in a murder conviction, and the case became the subject of two television documentaries as a "no body" homicide. In 2012, he was assigned to the Republican National Convention, and was responsible for the operation of undercover assets. Presently, he is assigned to a Violent Crime/Gang squad.

#### FDOT SECRETARY JIM BOXOLD



Jim Boxold was named Secretary of the Florida Department of Transportation by Governor Rick Scott in December 2014. advertising portfolio. Bill is an Outdoor Advertising Association of America Hall of Fame member and is one of the original members of the OAAA digital signage committee. He currently serves as the committee chairman.

#### **MARIAN JOHNSON**



Marian Johnson is Senior Vice President of Political Strategy for the Florida Chamber of Commerce, Florida's largest business federation, representing 139,000 companies, associations, state and local chambers. She also serves as the Executive Director of the Florida Chamber Political Institute, a unique research organization that provides vital detailed demographic and political analysis to its members. Johnson, perhaps Florida's most seasoned political advisor, has been involved in an impressive number of presidential,

state and local campaigns. Her budding career started in 1964 when as a high school senior she became fascinated with the "Barry Goldwater for President" campaign.

Since then, she has gained experience in every facet of political operations, from campaigning to research and polling to administration. Johnson holds a PhD in Biblical Studies and PhD in Biblical Counseling and is listed in Who's Who in American Politics, Prominent People in Florida Government, and Outstanding Young Women of America. She was appointed by U. S. Senator Mel Martinez to serve on the Military Selection Board.
